



WALT DISNEY WORLD® MARATHON WEEKEND – January 7-9, 2011

SPECIAL OFFER IN HONOR OF *TEAM NACoA*'s 10TH YEAR PARTICIPATING IN THIS MAGICAL WEEKEND

To celebrate our 10th Anniversary, NACoA is rolling back our donation requirement to the amount that we asked our runners to raise the first year that *Run for the Children*® participated in the Walt Disney World® Marathon Weekend. We will also provide a free hotel room for each of our runners as we did our first year.

WALT DISNEY WORLD® Marathon runs through all four WALT DISNEY WORLD® Theme Parks beginning in Epcot®, continuing through the Magic Kingdom®, Disney's Animal Kingdom®, Disney - MGM Studios® and returning to Epcot®. The Half Marathon race begins in Epcot®, runs through the Magic Kingdom® Park and returns to Epcot® for an exhilarating finish. The half and full marathons will be held separately on 2 consecutive days.

- The full marathon is open to runners and walkers age 18 and over who are able to complete the 26.2-mile course within a 7-hour time limit. This race is on Sunday, January 9, 2011. The half marathon is open to runners and walkers age 14 and over who are able to complete the 13.1 -mile course in a 3.5 hour time limit. This race is on Saturday, January 8, 2011. The Goofy's Challenge requires a special Goofy's Challenge registration. The Goofy' Challenge race is running or walking both the half and full marathon. You will not receive the Goofy Medal unless you are registered as a Goofy's Challenge participant.
- Participants must complete the registration form in full and mail or fax it with the non-refundable deposit of \$100 for either the Half or Full marathon or \$200 for the Goofy's Challenge.
- Each participant will be required to raise a minimum contribution of \$1500 (Full, Half, or Goofy) by race weekend.
- Each participant will be responsible for any balance of the minimum required still outstanding on race day.

Participant Package Includes:

Registration race packet includes an official WALT DISNEY WORLD® Weekend program, commemorative participant shirt, finisher's certificate and medallion. *TEAM NACoA* will provide a pre-race pasta dinner and rally, pre-race breakfast, goodie bag, *Run for the Children*® T-shirt (to be worn during the race), a post-race celebration event and NACoA will provide up to 2 nights hotel accommodations for each *Run for the Children*® registered runner.

Special Incentives:

Participants who raise \$500 or more over their required fundraising amount **by 12/01/10** qualify for air transportation reimbursement up to \$300/registered runner.

- Pay by credit card or check made payable to the National Association for Children of Alcoholics.
- Participants are required to make all arrangements for their own transportation.
- Whether you are an experienced marathoner or just getting started, our comprehensive training program for both runners and walkers includes training schedules, training and fundraising tips, periodic newsletters/e-blasts and our coach, who is available via phone or e-mail
- Upon receipt of your registration commitment, you will receive a complete *TEAM NACoA* e-mail packet with all the materials and information you need to do your fundraising and to get started preparing for NACoA's *Run for the Children*® in the WALT DISNEY WORLD® Marathon, Half Marathon or Goofy's Challenge.

NOTE: In the event a participant must withdraw from any of the races neither the commitment fee nor contributions already received by NACoA will be refunded.
